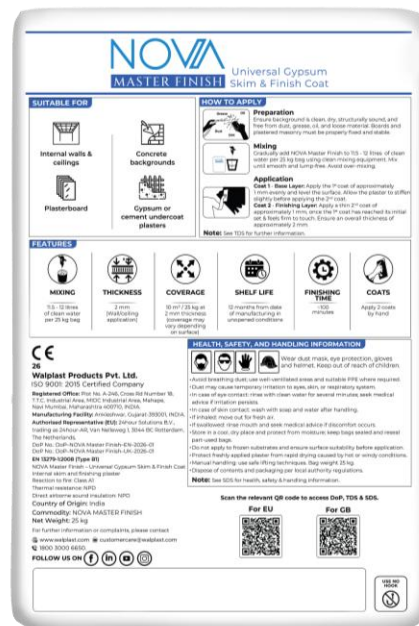

SECTION 4: First aid measures.

4.1 Description of first aid measures:

Inhalation:

- Move to fresh air
- Rinse mouth and gently clear nasal passages if necessary
- Seek medical attention if symptoms persist

Skin contact:

- Wash with soap and warm water
- Apply moisturiser if dryness occurs

Eye contact:

- Skin dryness from prolonged contact

6.3 Methods and material for containment and cleaning up:	- Sweep or vacuum using low-dust methods (avoid dust generation) - Do not wash into drains (sets solid) - Dispose of collected material in accordance with local UK waste regulations

7.1 Precautions for safe handling:	- Provide adequate local ventilation during mixing - Avoid breathing dust - Use appropriate PPE - Avoid contact with moisture prior to use
